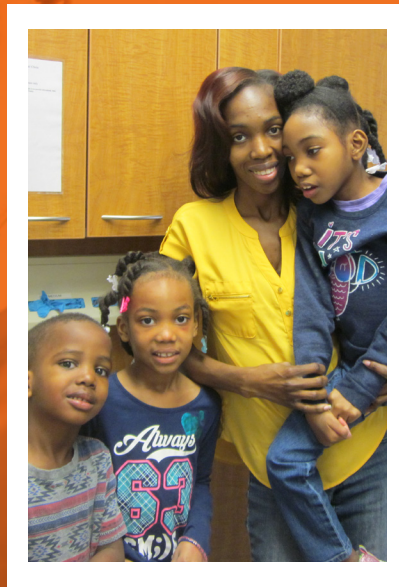
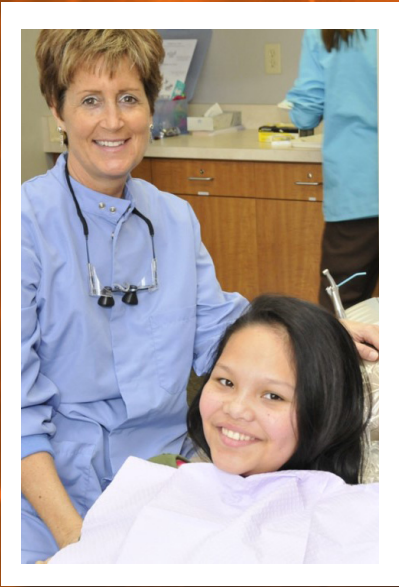

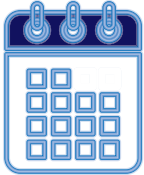

# 2017 Oral Health Impact Report

The comprehensive and compassionate dental care we provide at the Waukesha County Community Dental clinic has positively impacted more than 13,500 disadvantaged Waukesha County residents and remains consistent with our mission to improve the dental health of low-income Waukesha County residents through preventive and restorative treatment, oral health education, and advocacy.

## SINCE OPENING IN 2008:

**7,601** children have had a dental home  
**5,956** adults have had access to dental care and have avoided a trip to the ER  
Value of Dental Care Provided - **\$13,000,000**  
Total Appointments since May 2008: **67,031**  
On May 20, 2008, the clinic saw **5 patients**  
On May 8, 2017, the clinic saw **45 patients** (currently a typical day)

## HEALTHY SMILES FOR TOTS & TEENS DENTAL PROGRAM

Research shows that maintaining good oral health is important for children. Dental decay impacts eating, growth and development, speaking, and learning. It results in missed school and missed work for parents who are caring for their children. Unfortunately, there are many low-income children in Waukesha County who do not have a dental home because their parents do not have the means to pay for regular dental care.

All children served receive oral health education, exams, x-rays, cleanings, sealants, fluoride varnish, and restorative care. Toothpaste, toothbrush and floss are provided at every appointment. In 2017:

- 3117 children have a dental home and understand the importance of good oral health.
- 84% of these children return for their 6-month appointment.
- 74% return without new decay.

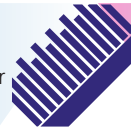
## ORAL HEALTH OUTREACH PROGRAMS

Outreach activities are conducted by our Community Dental Health Coordinator (CDHC) to identify low-income children in Waukesha County who do not have a dental home.

The Waukesha in School Sealant Program provided 1200 second and third grade students with oral health education, and 395 children received a dental screening and sealants application.

The WCCDC also offers free screenings of children in Head Start and daycare programs, and free exams and comprehensive care for children through our Give Kids a Smile Day events.

Our CDHC makes presentations to pediatricians, free clinics, food pantries, shelters, churches, and other organizations that serve low-income families.



## SPECIAL SMILES DENTAL PROGRAM

The Special Smiles Program provides a dental home to adults with physical, developmental, cognitive and behavioral disorders. Referrals are made by Children's Hospital, St. Anne's Center, Lad Lake, local dentists, and other partners. In the past year the program served 100 patients.

## HEALTHY SMILES FOR MOMS AND BABIES PROGRAM

Improves the oral health of low-income pregnant women and their newborn babies. The program is conducted in partnership with the Waukesha County's Women, Infant and Children's Nutrition Program (WIC) and other local programs that reach at-risk pregnant women. The WCCDC Community Dental Health Coordinator (CDHC) conducts onsite outreach and pre-screening services one day per week at the WIC clinic to identify women who are high risk and needing dental care. In 2017, 87 moms and babies participated in the program setting those families up for better oral health habits for a lifetime.

# 2017 Financial Position

At the Waukesha County Community Dental Clinic, we practice sound fiscal management and take our obligation very seriously to our donors to use contributions wisely. In conjunction with the Board, our Finance Committee prepares the budget and reviews monthly.

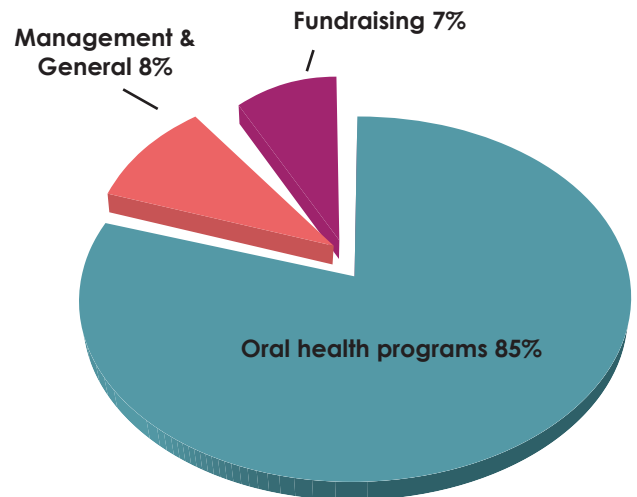

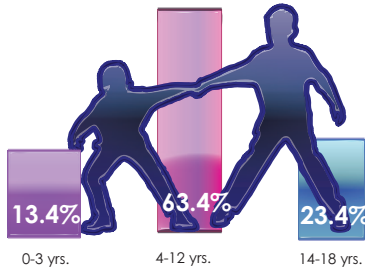

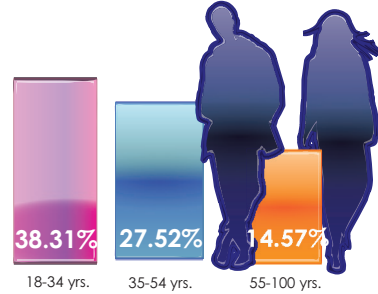

## ProHealth Care & Froedtert Generosity Supports WCCDC Growth

**A bit of history:** More than 12 years ago, ProHealth Care nurses and a group of health-focused organizations from around Waukesha County met to address a severe lack of access to affordable dental care to lower-income children and families. This group, along with ProHealth Care, successfully raised funds to build the Waukesha County Community Dental Clinic (WCCDC), which opened in May 2008, with a goal to break the cycle of poor oral health in families across Waukesha County.

**A special thanks:** Since its inception, the WCCDC on Barstow Street in Waukesha and the administrative offices at the Professional Office Building have been generously donated by ProHealth Care. Thousands of lives have been changed for the better because of this yearly, foundational gift, and we are deeply grateful.

**Growth and expansion through generosity:** Access to affordable dental care continues to be an issue across Wisconsin, and many private practices don't accept (or limit) patients covered by Medicaid programs due to low reimbursement costs. In November 2017, it was announced that a second site for the WCCDC would open in 2018 - an expansion to Menomonee Falls that is made possible by a \$1.65 million gift from Froedtert Health. The clinic in Menomonee Falls will enable the WCCDC to eventually double its impact on oral health. Our deepest gratitude to our partners at Froedtert Health for laying the groundwork to make more smiles healthy and happy.

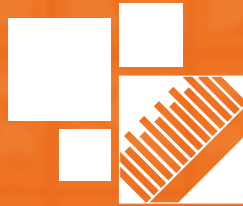
